

The regular meeting of the Adams Township Board of Supervisors was held on May 10, 2021 at 7:00 p.m. at the Adams Township Municipal Building, 690 Valencia Road, Adams Township, Mars, PA.

On a motion by Edward L. Vogel and seconded by Darryl M. Brandon, the Callery Fire Department Report for April was approved. All were in favor.


TREASURER'S REPORT
