The regular meeting of the Adams Township Board of Supervisors was held on May 9, 2022 at 7:00 P.M. at the Adams Township Municipal Building, 690 Valencia Road, Adams Township, Mars, PA.

Present at the meeting were Supervisors Russell R. Ford, Ronald J. Shemela, Edward L. Vogel, Ronald G. Nacey and Darryl M. Brandon; Solicitor Michael Gallagher, Township Manager Gary Peaco, Chief of Police Shawn Anglum, Park Director Haley Zaliponi and Assistant Secretary Andrea Dunton.

Chairman Ford called the meeting to order at 7:05 P.M. with the Pledge of Allegiance.

### **PUBLIC COMMENT**

Lisa Chodkowski, 125 Glade Run Road, attended the meeting to relay her concern regarding the proposed Rightmyer PRD Plan. Ms. Chodkowski stated that there are a proposed 11-12 homes that will be in an active floodplain if plan is passed.

Chairman Ford stated that the Board is aware of the preliminary plans and the concerns that have been brought forth, but there is a lot more work to be done on the plan before it gets in front of the Board of Supervisors. Mr. Ford stated that the Bored does not want to speculate on a plan that is still going through the process and has yet to be brought in front of the Supervisors.

Larry Kaufman, 239 Ridge Road, stated that he understands that the Board has requested there be no charges to the Township for Hydrants and that he was unable to find a motion to match this request. Mr. Kaufman asked why the Township is moving forward with taking bids.

Chairman Ford explained that there was no motion because there is no motion necessary for the request of nonpayment within a municipality owned authority. Mr. Ford said that the Supervisors are in a position to decide what is in the best interest of taxpayers and right now they are exploring those options.

Mr. Kaufman stated that, in his research, places like Penn America are triple the cost of what residents are currently paying.

Tim Stack, 240 Forsythe Road, requested that the Board of Supervisors force the Planning Commission members to complete an ethics form to help complete the picture for residents.

Township Solicitor, Mike Gallagher, stated that it is not a legal requirement of the Planning Commission Board members to fill these forms out.

Chairman Ford stated that since this is not required, he will leave it up to their discretion, but the Board cannot force them to do so.

Don Werner, 405 Blackstone, stated that the resident's opinions are what matter and that there will be a seismic shift in public opinion.
