### Village of Camp Trees Bond Release

Ron Olsen, Township Engineer, explained that he recommends a partial release of Performance Security for Village at Camp Trees phases 1,2 and 3 totaling \$118,744.18.

### **PUBLIC COMMENT**

Jim Mellin, 504 Providence Court, stated his opposition to the proposed sale of Water and Sewer Authority. Expressed concern having a bigger company take over, larger competition and losing control of water rates.

Jack Urling, 2033 Jamestown Court, asked the Board what the reason would be for a sale of the Water and Sewer Authority. He also thanked the Board of Supervisors for the upgrades on Three Degree Road.

Brian Fabish, 109 Hidden Oak Dr., asked the Board why we are considering an outside source for the Water and Sewer Authority if there are no issues.

Robert Koleno, 209 Oak Leaf Dr., asked the Board why he found out about the asset valuation of the Water and Sewer Authority from other residents rather than from the Board. He believes in transparency and didn't appreciate the secrecy.

Frank Thompson, 905 Pointe View Dr., stated that he received a letter from concerned residents and wanted more information regarding its contents.

Amy Martino, 905 Pointe View Dr., requested to see the asset valuation and budget numbers on future expansions that a potential sale would benefit.

Stacey Palmer, 214 Cliffside Dr., asked the board the date of the NDA agreement, why PA Water did not sign and if there was an extension granted since the NDA agreement expires end of month. Ms. Palmer also asked how it would benefit the Township if the authorities would be purchased in perpetuity which would cause the residents to pay. Mary Snow, 1030 Mars-Evans City Rd., stated that the Board should allow residents outside of Adams Township to speak since they will be affected by a proposed sale as well. Ms. Snow asked if the Board has the power to sell anything else and how long each Supervisors term is. She also stated that if these township authorities are working correctly, why would the Board consider this.

Russell Ford made a brief statement regarding the Water and Sewer Authority questions presented by residents. Mr. Ford stated that the Board of Supervisors requested a valuation of the Water Authority as a Township asset and if/when a time came that they would look into a sale, the public will be notified and able to discuss.
