Memorandum of Understanding with ATTACC

Darryl Brandon stated that the Memorandom of Understanding between ATTACC and Adams Township is for a long-term lease of property in the park for an aquatics center.

Ben Narwold, representative of ATTACC, stated that ATTACC is now an approved nonprofit. ATTACC is currently conducting a feasibility study with residents. Mr. Narwold also stated that there is nothing like the proposed aquatics center PA and that there is great need for it. The aquatics center will also have a fitness center and track.

Tina Wilson, 105 Good Luck Lane, asked the Supervisors if the MOA will be public Knowledge. Darryl Brandon said yes.

Tim Stack, 240 Forsythe Rd., stated that he doesn't believe many people want this size of a pool. Mr. Stack believes this is an unprecedented size for this area and adds to his beliefs of development problems in the area.

Public/Private Road Ordinance Public Hearing Date
