 - b. All gates need to be self-closing and self-latching.
 - c. All electrical inspections have been performed by third-party Electrical Inspector.
 - d. If you do not have an auto cover, there should be a stand-alone alarm on any doors or windows having a sill height of less than 48" that have access to inside fenced area around your pool. Windows having a sill height of 48" or greater are exempt.
8. Certificate of Occupancy from Township after a PASSED final inspection: _____

The Final Occupancy responsibility falls on the permit holder/homeowner. It is not the township's responsibility to make sure the permit is closed/finalized. The permit will expire or be void if the project isn't completed within 180 days, or no work commences for a time frame of 180 days. A time extension may be permitted with consent from the Code Enforcement Officer.

A Certificate of Occupancy will not be released without a passed final inspection from the Adams Township Code Enforcement Officer/Assistant.

- 5.) **Two copies of drawings/project**
- 6.) **Contractor's Insurance**
- 7.) **H.O.A. (Homeowners Association) Approval letter if applicable**

Information Required for Building Permits

- 1.) Along with a completed Building Permit application, a site plan (plot plan) showing the location of the proposed new construction on the property relative to property boundaries and abutting streets.
- 2.) Construction plans shall be drawn to scale and shall be of sufficient clarity to indicate the nature and extent of the work proposed and shall show in detail that it will conform to the provisions of the **2021 IRC** as amended.
- 3.) If you live in a community that has an H.O.A. (Homeowners Association) you must provide a copy of the association's approval of your project
- 4.) Any additional information that the Code Enforcement Officer may require to secure conformance with Township, County, State or Federal laws must be submitted.
- 5.) Upon completion of the project and prior to **OCCUPANCY**, a final inspection must be Finished, and an Occupancy Permit must be issued. **This applies to all Pool Projects.**
